

Terms and Conditions

Fanmade History – EHF FINAL4 merchandise design contest 2023

- By submitting, you agree that EHF Marketing GmbH (hereinafter referred to as “company”) has the right to use the design awarded in this contest (hereinafter referred to as “awarded design”) and the winner consents to not raise any sort of objection. EHF Marketing GmbH has the right to alter and adapt the design in order to fit the competitions brand identity and requirements for the final printing file.
- In entering the contest, participants confirm that they are eligible to do so and eligible to claim any prize you may be awarded.
- The winner is responsible of tax and public charges (taxes generated from the prize money).
- All rights to the winner’s submission belong to the company to the extent permitted by relevant laws and regulations, and in no event shall the winner require any compensation other than the compensation paid and the prizes awarded for the use of the artwork on official EHF FINAL4 2023 merchandise
- Entries in the contest will need to be original work and should not violate the rights of third parties or related laws
- The company will not accept entries that are not originals, photocopies or that are incomplete. Entries on behalf of another person will not be accepted.
- In the event of a dispute related to an entry, the company shall not be obliged to intervene in disputes between the participants and/or between third parties, and the company shall not be liable to compensate for any damages.
- In addition, the participant is responsible for all disputes related to their submissions.
- The company is not responsible for any issues with creation, disclosure, distribution, etc. of the participant’s submission, and the company is not responsible for damage compensations.
- The winner must submit his/her original files (.PSD, .AI, PNG etc.) of his/her work. Please hold on to your original files.
- When the company uses the awarded design, the winner agrees the work may be transformed or reconstructed.
- The awarded design can be used by the company for promotional purposes.
- The awarded design will be featured and sold on the official EHF FINAL4 2023 merchandise.
- Prizes will be granted within two months of the announcement of the winners.
- The company has the right to cancel, change or discontinue the contest without notice or consent of the participant in the event of any fraud or other circumstances affecting the fairness or integrity of the contest. This privilege is valid regardless of whether the contest is due to a human or technical error. If we cannot find a solution to restore the integrity of the contest, we have the right to select the winner from all eligible entries received prior to cancellation, modification, or suspension of the contest.
